Trees have become excessively large and overbearing for an urban garden.

T1 Large Lime - Reduce crown back to previous points of reduction (3-4m off height, 2-3m off width).

T2-3 Limes - Cut all overhanging branches back to boundary. Reduce height by 2-3m, bring in lateral branches to create a balanced crown.

T4 Pear - Reduce height by 25-30% and shape crown to balance.

T5 Large Beech - Reduce back overhang towards house by 3-4m.
