Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.

Raise lower branches over gardens to a height of 9-10 metres to improve light penetration to understory plants.

Reduce crown spread laterals over gardens no. 24 and no.22 by approximately 3-5 metres to reduce the risk of branch failure.
