Ash: The mature ash located on the left hand side of the access drive. Fell to ground level. Reasons: Ambulance was not able to get down the drive and the elderly lady who lived there requires constant available ambulance access. In addition to this, there is a large fruiting body at approximately 8.00m up the main stem. There appears to be a large cavity with a longitudinal wound at the decay pocket. Client is happy to re-plant.
