2 x Cedar: Approximately 18.00m. The two cedar trees growing on the right-hand boundary appear in good condition and are fine specimens. Several branches growing towards and overhanging the property have grown close to and in some instances, are touching buildings. Remove dead wood throughout the crowns, reduce branches overhanging buildings by 2.00-3.00m to ensure reasonable clearance of structures whilst preserving tree health. Reduce one low branch over patio area by 2.00-3.00m to increase light levels.
