Rear Garden:

Bay: Located in right hand corner. Reduce crown height by approximately 40%, reduce remaining crown by 30% to balance, raise crown to clear fencing and prevent further damage approximately 0.50 to 1.00m. Reasons; help curtail the tree's sphere of influence, abate nuisance to neighbouring property owners and increase light levels to 4 Albert Terrace whilst preserving screen, the trees natural characteristics and aesthetic value.
