- Following recent high winds, we examined a Birch Tree in the rear garden of 5 Eldon Grove. Surface roots of this tree showed definite movement and the adjacent slabs had been lifted from there previous position.

In Addition, the main stem of the tree has a significant cavity (see photograph) It is our opinion that as this tree stands it is a hazard and we seek consent for its removal.
