The proposed works are to utilise the existing poster boxes and frames. A new large banner is to be erected over the main entrance off Charing Cross Road to announce the forthcoming show. This is to be fixed to the columns using existing fixings, which have been designed as part of a previous application. The fixings allow for signs to be installed without obscuring the entire view of the elevation. The existing canopy facades are to have new show related inserts. The large corner banner has been increased in size to cover more of the brickwork to the elevation. The Phoenix Street elevation is mainly proposed signage within existing display advertisements areas.
