Proposed Work:

REAR GARDEN: 1x Cherry (T1) Reduce crown height by 4m, reduce lateral branches by 3m, prune to suitable growth point to form a symmetrical shaped canopy.

1x ACER (T2) - Reduce crown height and lateral branches by 3-4m, prune to suitable growth points to form symmetrical shaped canopy.

2x Elders (T3 & T4) - Fell as close as possible to ground level.

1x LIME (T5) - Reduce crown height by 3-4m, reduce lateral branches by 3-4m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.

1x ACER (T6) - Reduce crown height and lateral branches by 3-4m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.

The Council has considered your notification of intended works to trees dated 31 January 2018 and does not wish to object.
