Dear Oluwaseyi,

Thank you for consulting HS2 Ltd on the above matter, we have the following comments to make.

Firstly it is acknowledged that the proposed works are minor in nature, however from checking the applicant's submitted location/site plan with HS2 safeguarding map records I can confirm the proposed telephone kiosk would be sited within limits of land subject to the formal Safeguarding Directions (sub-surface interest) for Phase One of the HS2 project. Following consultation with colleagues in the Phase One Construction team I am also advised that the proposed kiosk sits within Limits of Land to be Acquired or Used (LLAU) for HS2 and the land in question is therefore potentially required for delivery of the project. As the works could also interfere with HS2 Ltd's appointed contractor's proposals for this area and in the interests of avoiding any clashes of works and/or associated abortive costs, (should the kiosk need to be relocated in the near future), it is requested that that the kiosk be re-located outside the HS2 area of interest.

In procedural terms HS2 Ltd acknowledges that as this is not an application for planning permission and as a consequence the formal Safeguarding Directions are not engaged. It is also acknowledged that there is no legal obligation on the Council to formally consult HS2 Ltd on the prior approval application and any representations that HS2 Ltd make do not bind the Council or cause the application to be referred to the Secretary of State for Transport in the way that they would if it had been a planning application.

However, HS2 Ltd also recognises that telecommunications development falling within the category of permitted development under the GPDO must follow the prior approval determination procedure, under which the Council is given the opportunity to say whether it wishes to approve details of the 'siting' and 'appearance' of the proposed installation and no other factors can be considered by the Council for this type of application. Factors concerning 'siting' may involve, amongst other things, height of the site in relation to surrounding land, topography of the site and vegetation, openness and visibility of the site and <u>designated areas</u>, (my emphasis).

Accordingly the Council and the applicant should be aware of the potential clash between the proposals and the HS2 planned works in advance of determining the application and HS2 Ltd cannot support the permanent siting of the proposals in their current location and recommends that the London Borough of Camden refuses to approve consent for them. As mentioned above, the suggested remedy to deal with these concerns would be to relocate the kiosk outside of the HS2 area. In the event that suggestion is not acted upon, when determining the application HS2 Ltd suggests the following wording for a reason for refusal:

## **REASON FOR REFUSAL:**

'The proposed development would conflict with the HS2 safeguarded route as published, and would impact on the ability to build and operate HS2 and the Government's objective of delivering HS2, which is an infrastructure project of national importance. The proposal is therefore contrary to Government Guidance contained in the National Planning Policy Framework (NPPF) and the Safeguarding Directions for development affecting the route and associated works for the High Speed Two rail project — Phase One.'

We would welcome a copy of the decision once it is available and if it would be of assistance HS2 Ltd would be happy to discuss the issues raised in this response with the Council and/or the developer directly.
