T1: Weeping Ash (*Fraxinus pendula*) – 40% Pollard at 1-2 m above crown break. Tree is not the healthiest, aiming to contain canopy and make the tree safer.

T2: Lime (*Tilia europaea*) – reduce by 25-30% to contain canopy and remove any major deadwood over 50mm, lift on the roadside and strip ivy.

T3: Silver Maple (*Acer saccharinum*) – reduce by 25-30% to contain canopy and remove any major deadwood over 50mm, lift on the roadside.

My client (Mr Barber) has informed me that he has historic ownership of Trees T2 and T3 which are situated at No10 Fitzroy Park.
