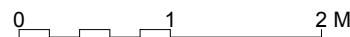

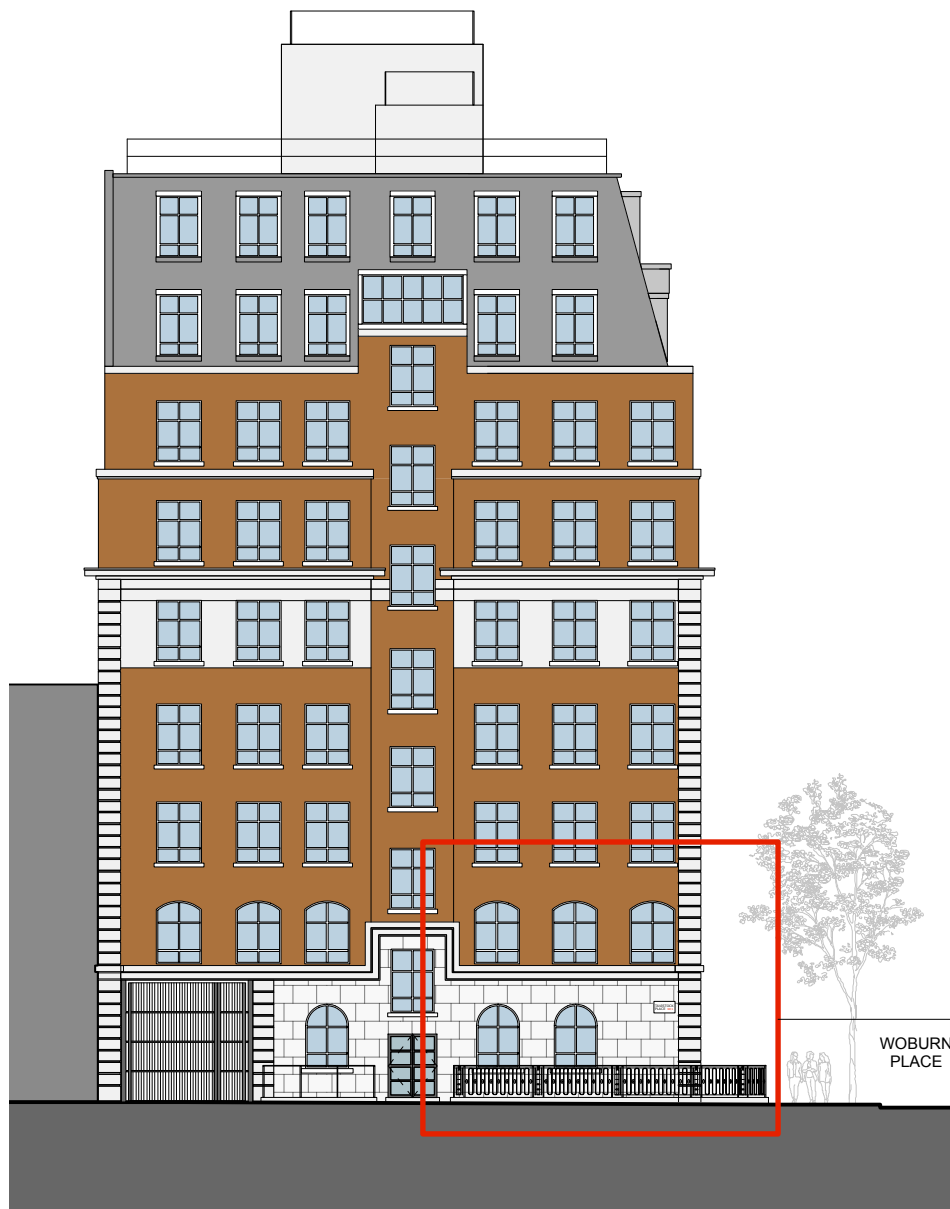

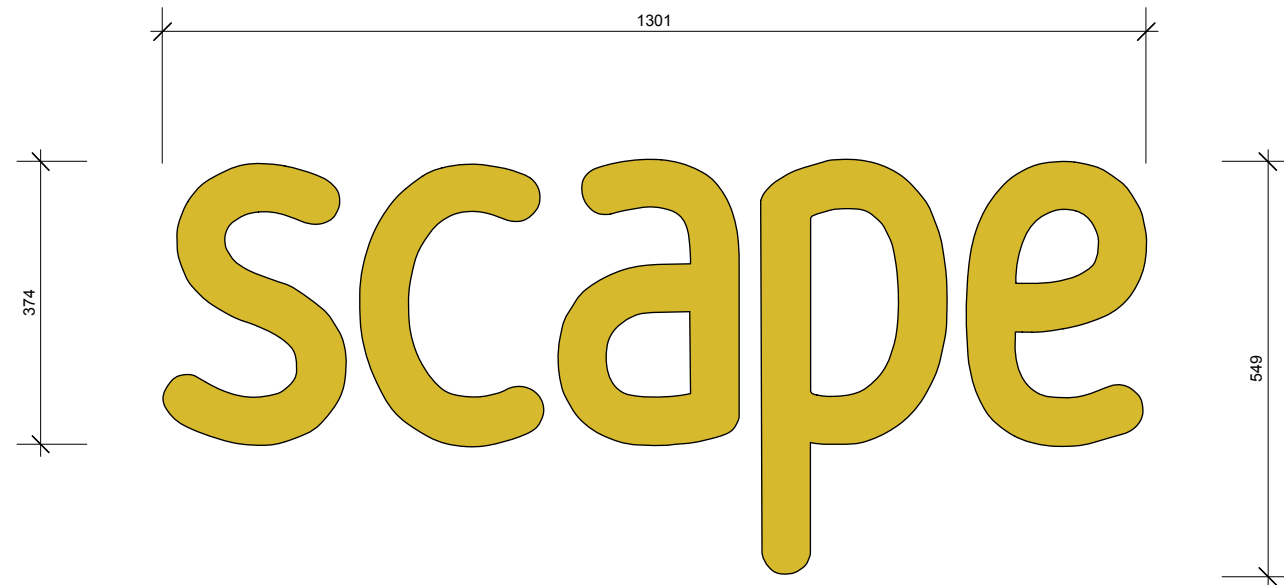

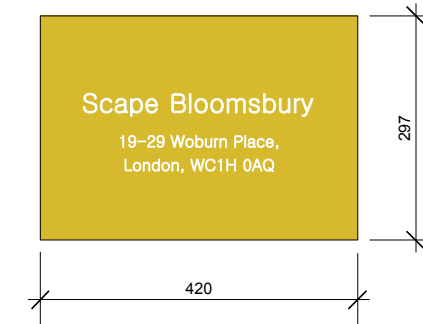

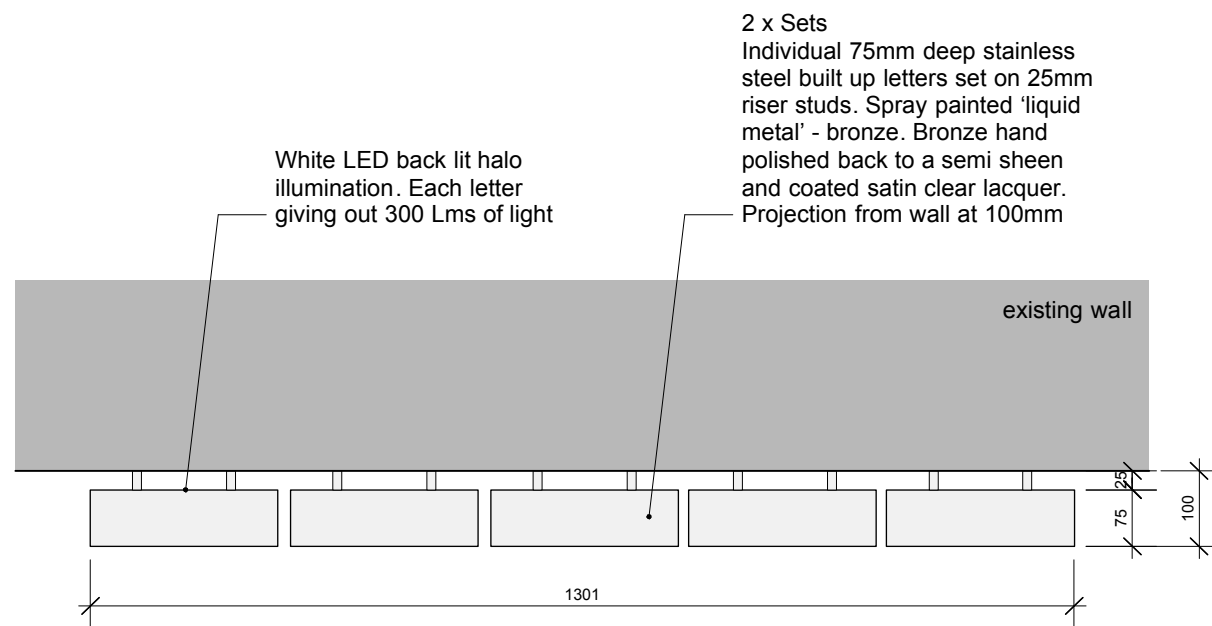

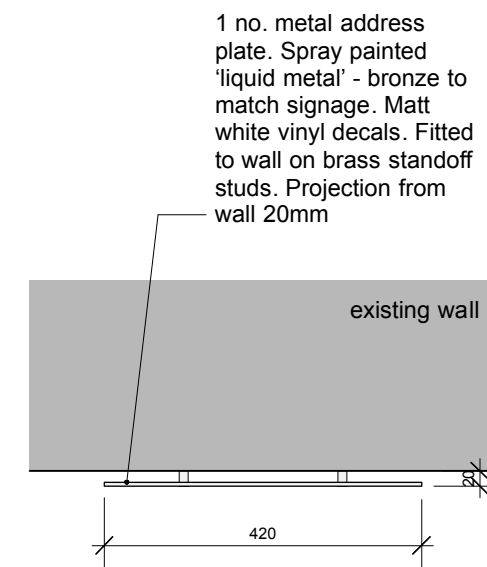
1 Signage Elevation
