REAR garden (no side access)
GRP1 = Large mixed vegetation encroaching onto garden of No.20 –
Face back to boundary line.

T1 = Medium BAY - Reduce crown by 1m and lightly reshape.

T2 = Medium CONIFER - Cut back by 1m from boundary line.

GRP2 = Medium mixed vegetation on boundary wall - Cut height by 0.5m to height of rear wall.

T3 = Medium ELDER - Cut back 1 x limb encroaching on garden (see pic).

7. Identification Of Tree(s) And Description Of Works

T4 = Large LIME very close to boundary wall - Fell as close as possible to ground level.

T5 = Medium SHRUB - Cut back vegetation to boundary wall that is suppressing Hydrangea.

T6 = Medium ASH - Lightly reduce height by 0.5m and reshape.

FRONT garden

GRP3 = Medium IVY growing on front elevation - Remove.

T7 = Small Self-set Ash sapling - Fell as close as possible to ground level.
