The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans:

Reason: For the avoidance of doubt and in the interest of proper planning.

- 3 Reasons for granting permission:

The proposal seeks to install two new roof lights on the flat roof of the subject property. The appropriate design, materials and minor nature of the proposed works are considered to appear as unobtrusive additions. Their minor projection from the roof and limited visibility from the public realm would ensure that no significant harm is caused to the appearance of host building or surrounding area.

Given the minor nature and siting of the proposed works, the proposal would not harm the amenity of adjoining occupiers.

No objections were received prior to making this decision. The planning history of the site and surrounding area were taken into account when coming to this decision.

As such, the proposal is in general accordance with Policies D1 and A1 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework 2012.
