T1 Sycamore Acer pseudoplatanus Rear garden of no. 37 Mature specimen with a slight lean towards the Ampton Street properties. Windsail reduction is proposed to mitigate root development proximate to the surrounding properties, to ensure the tree is structurally stable and to mitigate damage to the boundary wall. Work specifications: Reduce height by 4.5m, shape the crown and reduce lateral growth by 2m (to previous reduction points). Sensitively extract arisings through the property of no. 39.

T2 Fig Ficus carica Rear garden of no. 41 Tall specimen, unsuitable for fruiting at this height and unmanageable for the elderly resident. Reduce height to 2m. Extract arisings through no. 39.
