**I am writing to you regarding application 2016/2335/P**

Please find attached the decision notice for the application for your reference.

I would like your advice regarding:

1. The application to temporarily change the use of the jubilee waterside centre into an educational (class D10) is only valid until **August 2018**.

- What would be required to submit a new application to application 2016/2335/P

**The submission should include the same documents as the previous application i.e. site location plan, drawings, revised Transport statement (reflecting impact of uplift of 60 students)**

2. We intend to change some of the internal layouts to facilitate two more class rooms (equating to 60 more pupils)

- Does this require a new application?

**Whilst internal alterations can be carried out without planning permission, the forthcoming planning application should reflect the proposed internal rearrangement**

- Will we need to submit a new transport statement?

Given the uplift in student numbers, a revised transport statement would be required.
