The proposed details/samples of materials including the Tambora Grey, Old Forge, Essex Yellow Stock, Anglian Weathered and Titanium Grey brick samples inspected on site; the sandy/grey mortar sample inspected on site; the white painted pre-cast concrete cills, lintels, mullions and coping details; the timber framed sash windows, timber casement windows and metal framed windows; the Spanish roof slate sample inspected on site; the smooth white render specification for the basement lightwell elevations; the clay chimney pots and roof finial details and the roughcast render/Mock-Tudor half timbering would all harmonise with the character and appearance of this terrace and would preserve the character of the conservation area in accordance with policies D1 and D2 of the London Borough of Camden Local Plan 2017.
