The existing climbable, metal mesh fencing on Langtry Road is proposed to be replaced with a more robust and secure steel pale-through-rail, black, Barbican style fencing. The height of the existing 2m section of fencing is inadequate and it is proposed to be increased to an overall height of 2.5m. The fence wraps around the front left corner of the site between the front entry gate and the adjoining flats on the side boundary. This section of fence is ranging between 2m – 2.5m in height, however it is effectively reduced to 1m in height from the side of the neighbouring flats due to front stairs and bin location.
