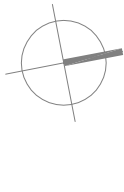

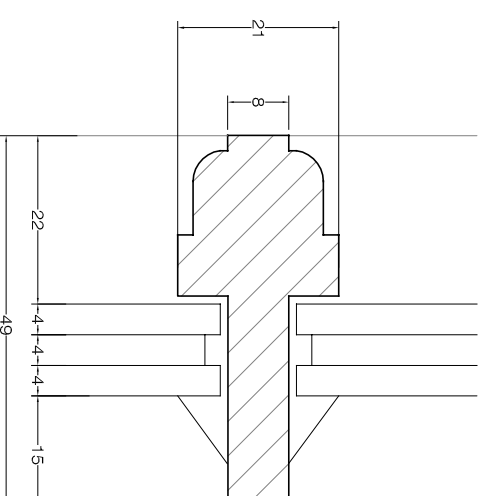

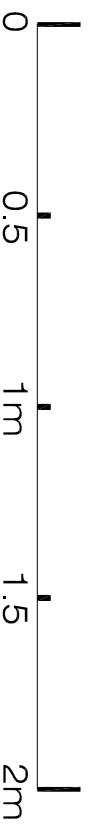
EXISTING WINDOW
