Proposal:

Replacement of existing timber front door with a new timber front door to basement flat (Class C3).

Drawing Nos: Design and Access Statmenet; 3 x Photos; 3808/WM/01; 3808/WM/02 R-2; 3808/WM/03.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise

specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans: Design and Access Statement; 3 x Photos; 3808/WM/01; 3808/WM/02 R-2; 3808/WM/03.

Reason: For the avoidance of doubt and in the interest of proper planning.

- 4 The door hereby approved is to be painted in the same hue of grey to match existing.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

Informative(s):

- 1 Reasons for granting permission:

The proposal seeks to replace a timber door with like-for-like door (design and material) in response to the poor condition of the existing door to a flat within a block of residential units.

The original design and material (composite) of the replacement door were considered to be unacceptable. Although the building is a 20th century modern construction and of no heritage value, it has, however, some group value characteristics in terms of the pattern of fenestration and openings throughout the block. The initial design of the replacement door departed from the group value of the neighbouring doors. In order to retain the sense of rhythmic details, the new door should reflect what is currently in place within the block and thus revisions were requested.

The amended proposal consists of a like-for-like timber door and is considered to be acceptable in terms of its size, design, location and material to be used. The new door would preserve the character and appearance of the host and adjacent buildings, the conservation area and the streetscape.

The site's planning and appeal history has been taken into account when coming to this decision. No comments were received following the statutory consultations.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with policies of the London Plan 2016; and the National Planning Policy

Framework.


