Proposal:

Replacement of existing partially single glazed timber door with new partially double glazed timber door to upper ground floor flat (Class C3).

Drawing Nos: Design and Access Statement; 3666/WM/01; 3666/WM/02 R-2; 3666/WM/03.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1and D2 of the London Borough of Camden Local Plan 2017.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: Design and Access Statement; 3666/WM/01; 3666/WM/02 R-2; 3666/WM/03.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission:

The proposal seeks to replace a timber frame door with 4 glazing panels with likefor-like door (design and material) in response to the poor condition of the existing one.

The original design and material (composite) of the replacement door were considered to be unacceptable. It was felt that the replacement door should match the existing timber frame with glazing panels surround that is framing the door to the left and above, and thus retain the integral design of the entrance of the host red brick Victorian property. The originally proposed composite material would also not be in keeping with the traditional timber frame sash windows and doors found within the frontage of the property and its neighbours.

The amended proposal now consist of a like-for-like timber framed door with 4 glass panels and timber surround and is considered to be acceptable in terms of its size, design, location and materials to be used. The new door would preserve the character and appearance of the host and adjacent buildings, the conservation area and the front streetscape.

The site's planning and appeal history has been taken into account when coming to this decision. No comments were received following the statutory consultations.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with policies of the London Plan 2016; and the National Planning Policy Framework.

2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape,

access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Judd St, Kings Cross, London NW1 2QS (tel: 020-7974 6941).

3 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974.
