Proposal:
Replacement of existing timber door with a new timber door to communal entrance (Class C3).
Drawing Nos: Location and Block Plan; 3568/WM/ (01, 02R-2); Design and Access Statement.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

- 2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

- 3 The development hereby permitted shall be carried out in accordance with the following approved plans; Location and Block Plan; 3568/WM/ (01, 02R-2); Design and Access Statement.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

- 1 Reasons for granting permission.

The proposal seeks to replace a timber door with like-for-like door (design and material) in response to the poor condition of the existing one.

The original design and material (composite) of the replacement door was considered unacceptable. It departed from the group value of the door with its neighbours and not in keeping with the mid-19th century townhouse noted to be a positive contributor. As such, it was expected that the original feature of the door should be retained.

The amended proposal consists of a like-for-like timber 2 vertical panel door and is considered to be acceptable in terms of its size, design, location and materials to be used. The new door would preserve the character and appearance of the host, the conservation area and the streetscape.

The site's planning history has been taken into account when coming to this decision. Rochester CAAC raised no objection, but did comment that solid panels would have been original. However, the Conservation officer did confirm that the mid-terrace townhouse appears to contain its original 2 vertical panelled upper ground floor entrance door, which contributes to its overall character and has group value with neighbouring properties. No other comments were received following the statutory consultations.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with policies of the London Plan 2016; and the National Planning Policy Framework.

- 2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between

dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Judd St, Kings Cross, London NW1 2QS (tel: 020-7974 6941).

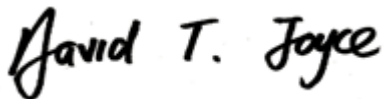
- 3 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Noise and Licensing Enforcement Team, Camden Town Hall, Judd St, Kings Cross, London NW1 2QS (Tel. No. 020 7974 4444 or search for 'environmental health' on the Camden website or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraphs 186 and 187 of the National Planning Policy Framework.
