Erection of advertisement hoarding to street frontage and end returns on the redevelopment of Parker House, 25-37 Parker Street WC2B. The hoarding is to display the development brand name, sales agent's contact details and website details. The hoarding is to be fixed to the existing hoarding line (contractors standard hoarding) within their agreed boundary. The hoarding will follow the standard height of the hoarding (approx 2.4m) along Parker Street. The construction is a 12mm shutterboard ply, painted with x4 back-lit illuminated logos. The area of Heras fencing will feature a plain pvc wrap to ensure privacy to the construction area behind. The illuminated logos are on low voltage LEDs - 12v, 1.2w per module, of 120 lumens/module. The hoarding is envisaged to remain during the duration of the construction programme till approx. May 2019.
