Tree of heaven (T1) (TPO no. not available) - Fell tree due to over dominance of its location within a small urban garden, close proximity to building located within a conservation area, roots effecting the foundations of the no.90 and no.88 Leverton Street and interference with the overhead lines crossing the properties rear garden. Its removal will have a negligible impact on public amenity.

Tree of heaven to be replaced with 2x silver birch tree (or other species with a vertical canopy as per tree officers recommendations). Tree to be planted with root barriers to help prevent interference with future neighbouring building foundations. These have been chosen due to their vertical canopy and eventual fully grown height of between 10 -12m, this is a similar height to the current tree of heaven which was last pollarded between 6-11m.
