We would like to reduce tree 1 by 25%, thin out the canopy by about 15%, and remove one of the branches growing closest to the house for safety purposes and for the aesthetics of the tree. This branch is about 10cm in diameter. These works are for general maintenance work as the tree hasn't been worked on for some time, for safety and to bring light in to the garden.

We would like to reduce tree 2 by 25%, thin out the canopy by about 15% and remove the low hanging branch which is growing over the school playground as this branch has dead wood scaring half the way up the branch. These works are for the general maintenance, safety and health of the tree. It hasn't been worked on for some time and would also allow more light in to the garden.

Tree 3 which is situated in the school grounds overhangs the driveway. We would like to remove about 3 small horizontal growing branches (5cm diameter) to prevent the pigeons from perching there and messing the forecourt area.
