Rear Garden:

Fig: Reduce height by approximately 30%, (approximately 1.50m above wall line). Reduce branches overhanging neighbouring property back to as near to the boundary as is practicable whilst preserving natural characteristics and aesthetic value as general maintenance.

2 x Eucalyptus: Located near to the rear boundary and certainly an inappropriate species for a small court yard garden. The tree nearest to the boundary has poor form and protrudes across two gardens. Both trees are not in particularly good condition and their proximity to the building may cause problems in the future. Smallest of two eucalyptus; fell to ground level and treat with systemic herbicide. Eucalyptus adjacent rear boundary wall; The main stem of this tree may in fact be supporting the boundary wall which looks weak and compromised. Fell the tree to wall height preserving the lower stem growing adjacent wall and treat with systemic herbicide.
