 The works hereby permitted shall be begun not later than the expiration of five years from the date on which this consent is granted.

Reason for Standard Condition:

1. In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

Additional Condition(s):

- 01 No work shall start on site without prior written notification of that start to The London Division of the Historic Buildings and Monuments Commission, Chesham House, 30 Warwick Street, London W1R 6AB, quoting date 12th July 1990 and reference LD3255/HT.
- 02 That all new works of making good to the retained fabric, whether internal or external, shall be finished to match the original work with regard to the methods used and to material, colour, texture and profile.
- 03 That detailed drawings or samples of materials, as appropriate, in respect of the following, shall be submitted to and approved by the Council before the relevant part of the work is begun:-
 - Council before the relevant part of the work is begun:
 (a) Any new railings, gates and alterations to paving in front of the retained Church facade;
 - (b) Any changes to the entrance doors;
 - (c) Any proposed advertising signs.
- 04 Before any work is undertaken in pursuance of this consent to demolish any part of the building, such steps shall be taken and such works shall be carried out as shall, during the progress of works permitted by this consent, secure the safety and stability of that part of the building which is to be retained.
- O5 The stained glass windows, memorial plaques and other architectural features from the part of the church to be demolished shall not be removed from the building before officers of English Heritage, London Division, have been consulted on their disposal.
- O6 No works of demolition shall take place until contracts have been exchanged for the redevelopment of the site in accordance with a scheme for which full planning permission has been granted.

- 01 As required by The Historic Buildings and Monuments Commission.
- 02 05. In order to safeguard the special srchitectural and historic interest of the building.
- 06 To protect the visual amenity of the area.
