Front Garden/Front parking area:

Pyracantha: Overhanging the parking area, not particularly attractive and causes nuisance. Fell to ground level and treat with systemic herbicide.

Rear Garden:

T1: Large Chestnut: Remove minor epicormic growth growing towards and touching the building.

T2: Large Ash: Approximately 18.00m. Remove dead wood throughout. Reduce section of crown overhanging the building by 30% to increase light levels and help abate nuisance.

T3: Twin stemmed Ash: Approximately 17.00m. Reduce the section of the tree growing towards the building by 30%.

T4: Purple Plum: Approximately 7.00m. The front limb of this tree is leaning on the boundary. We recommend; reduce broken leaning limb back to a suitable growth point.

G1: Yew Group: Approximately 5.00m. Reduce crowns by 30%, raise crowns by 1.00-1.50m.

All works are as general maintenance and to tidy and control encroachment.
