T2 Fig x 1 (Ficus carica) Remove large stem growing over the lawn and 5 x smaller stems from the same root system. Do not poison and leave neighbouring fig coppice

T3 Lime x 1 (Tilia spp) Previously reduced tress. Suggested Works: Crown reduce to previous pruning points (1.5-2m), clear the adjacent building by 2m, remove epicormics shoots, reduce lateral branches below crown break to 1.5m (by 3m) from stem and remove deadwood.

T4 Lime x 1 (Tilia spp) Previously reduced tress. Suggested Works: Crown reduce to previous pruning points (1.5-2m), clear the adjacent building by 2m, remove epicormics shoots, reduce lateral branches below crown break to 1.5m (by 3m) from stem and

Rear wall and neighbours wall

G5 Ivy Common x 1 (Hedera helix) Remove all Ivy from fence and both buildings.
