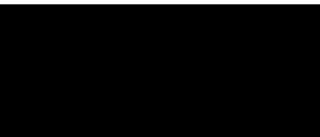
Thank you for your enquiry.

As the church is in the Highgate Village Conservation Area, any tree with a stem diameter of 75mm when measured at a height of 1.5m is protected. Assuming the tree in question meets this criteria, the council must be notified – and not object to – any works before they are carried out.

We can accept your enquiry below as a notification of intended works, although before we proceed, we will need to know exactly which tree you are proposing to remove so if you could provide a plan identifying this, we will be able to get this started.
