Thank you for allowing me to comment on planning application 2017/6986/P in relation to 24-32 Stephenson Way, NW1.

I do not have any objections to this application but have the following recommendations.

## **COMMENTS**

- The proposed cycle storage are in the basement should be protected with an encrypted FOB access control on a PAS24:24 2016 security rated door. I note there are two doors leading to this area, I would prefer to see only one on this room as it will be easier to control and monitor with CCTV. The proposed cycle storage racks should be Sold Secure Gold or Silver standard, which will allow for three points of locking for both wheels and the frame. Lockers should be security rated or secured with Sold Secure padlock to prevent personal property being stolen. The shower rooms should have ample locking if this area is going to be used by both males and females. FOB access should also be placed on the main entry door into the building for the use of cyclists and this should also be security rated to PAS24:2016.
- If access control is already fitted to the building then this should continue for the new floors. Ideally the lift should be FOB controlled isolating the movements of staff to the areas that they are only allowed to be in. This in conjunction with protecting the stair cores with access control will also assist in controlling movement. Each new office space will have access control before entry onto the floor.
- Any main entrance doors should be rated to LPS 1175 SR2 or STS 202, ground floor windows or ones that
  can easily be reached by climbing should be security rated to PAS24:2016. If they are non-opening windows
  then they should be reinforced with a minimum of P1A laminate.
