This exit consists of a single glazed timber sash window which currently closes down at floor level, but being a sash window, the upper part is obstructive and can be quite dangerous (especially for children) as it stands blocked at eye level. A more safe and friendly set of double glazed French doors is proposed, perfectly in line with many similar doors accessing balconies along the same road and all nearby roads (check attached pdf document with photos).
