The Council has considered your application and decided to grant approval of details.

Informative(s):

1 Reasons for granting approval-

The submitted details of mouldings and decorative architectural features, including the new revised arrangement of keystones around the existing gable roundels, are

considered to be acceptable in design and materials and to be appropriate for the character and appearance of the house and conservation area.

The full impact of the proposed development has already been assessed.

As such, the proposed details are in general accordance with policies D1 and D2 of the London Borough of Camden Local Plan 2017.

- 2 You are advised that the specific details of roundels shown on drwg nos 422.1 and 422.2 are not approved and are superseded by the revised details shown on drwg nos 210 and 212.
- 3 You are reminded that the following conditions of planning permission dated 21.9.17 ref 2017/4156/P are outstanding and require details to be submitted and approved-
conditions 4c (roof sample panels), 5 (fixtures), 6 (Hampstead Lane entrance), 7 (railings and gates), 8 (brickwork cleaning), 12 (part regarding protection of reptiles and amphibians around pond), 13 (wildlife landscape plan), 19 (waste), 21c (contaminated land remediation), 22b (stage 2 archaeology investigation), 27 (BREEAM measures evidence), 28ab (part regarding PV feasibility study, energy measures evidence), 29 (CHP), 30ab (drainage system details), 31 (drainage system implementation).


The applications submitted for conditions 9b (historic landscape), 9c (ecology enhancements), 16b (permanent lighting strategy) and 17 (green roofs) are being currently assessed and have yet to be determined.
