Thank you for consulting HS2 Ltd on this matter, we have the following comments to make.

As you can see from applicant's covering letter; "The relocation of the existing Melton Road docking station is required as part of the High Speed 2 construction works. The new location for which this application relates was selected jointly by Camden Council, TfL Cycle Hire and HS2. The existing cycle hire docking station on Melton Road will be removed in its entirety and reinstated appropriately."

The submitted proposals for the new cycle hire docking station at the above site have also been reviewed with colleagues within the HS2 Phase One teams and deemed acceptable given the current design and programme for HS2 construction in that location. Accordingly I confirm HS2 Ltd have no objections to the proposals in safeguarding planning terms.
