Rear Garden:  
Apple: This mature tree has collapsed onto the main lawn and the root plate has lifted close to the boundary. Fell to ground level, remove branch and cord wood.  
Large Holly: This tree affords good screen from the building to the rear but has become somewhat large and over dominant in its position. Reduce crown by approximately 30% and re-shape to balance whilst preserving screen, natural characteristics and aesthetic value.  
Aucuba: Cut hard back as required to facilitate new planting scheme.  
Laurel: This tree also affords screen but is somewhat thin and leggy. Reduce lateral and sub lateral branches overhanging the new planting bed hard back, 40-60%. Reduce crown height by approximately 1.00-1.50m to help induce thicker low growth whilst maintaining screen to roof height.  
Laurel: Located in left hand planting bed. This tree, although well shaped is now beginning to encroach heavily over the lawn. Some fairly radical pruning would in the short term leave the tree much less dense but allow for the regeneration of a smaller more compact crown structure. Reduce crown hard back over lawn as is practicable. Reduce crown height by approximately 30-40%, reduce remaining lateral and sub lateral growth to balance and shape.
