Rear Garden:

Large Plane: Reduce whole tree. Reduce back to previous reduction points whilst preserving a suitable amount of furnishing growth to maintain crown continuity. This large tree has been managed historically by pollarding. The tree has not been pruned for some eight to ten years and some maintenance work is certainly warranted to maintain the tree at suitable dimensions for its location. The tree overhangs 2 and 4 Perceval Avenue with the large part of the crown crowing within the curtilage of 5 Belsize Lane.
