

READ FIRST (May 2018) (v.2) Unit 4 and 22 – 24 Bagley Walk ('The Anchor Unit') Western Coal Drops Yard King's Cross Central

- We are seeking planning permission and advertisement consent for the fit-out of Unit 4 at Western Coal Drops – see general location plans of King's Cross particularly BEN 1, BEN 2 (1:1,250), a general plan of the regeneration area, BEN 001 and 002 for the application boundary red line plans. Within the red lines we are proposing: External seating areas for two restaurants (Barrafina at viaduct level and Plaza Pastor at yard level) including demountable canopy structure (viaduct level only) and at both levels for landscape planters; tables and chairs; lighting; and, ancillary restaurant facilities.
- 2. In support of the detailed planning application are:
 - Existing and proposed drawings for Barrafina (see attached schedule)
 - Existing and proposed drawings for Plaza Pastor (")
 - There are five photomontages:
 - View from the south east at viaduct level towards WCD showing the proposed Barrafina canopy and bar in the context of its setting, including the converted gasholder (BKX P09 SK A)
 - View from the south, again at viaduct level towards WCD showing the proposed Barrafina canopy and bar (BKX P10 SK A)
 - View from the north, again at viaduct level showing the proposed Barrafina canopy (BKX P11 SK A)

- View from the south east, again at viaduct level showing the proposed Barrafina canopy in a much wider context of East and West Coal Drops Yard (BKX P12 SK A)
- View from the south east, at yard level showing the proposed Barrafina canopy and Plaza Pastor in the wider context (BKX P13 SK A)

 Barrafina and Plaza Pastor

- 3. The red line for the planning application includes two outside levels, Barrafina is above Plaza Pastor. Each 'floor' is approximately 500 sqm in area, including public walkways and circulation space. The red line is therefore three dimensional see Plans BEN 001 and 002.
