Rear of No.30
T1 Silver Birch x 1 (Betula pendula / alba) This tree is growing from the boundary and it is having a huge impact on the neighbours light. Choosing the reduction option will not cut the tree back enough to minimise the overhang and impact on the neighbour. (Option A) Reduce all aspects of the crown by 3-3.5m, clear the building by 2.5m, remove Ivy deadwood and stubs.

(Option B) Fell in sections to ground level using rigging equipment to ensure a controlled take down.
