#### NUMBERING AND NAMING OF BUILDINGS

Regulations made by the London County Council on 29th July, 1952, under section 12 of the London Building Acts (Amendment) Act, 1939, relating to the marking of numbers and names of buildings.

- (1) Every number or name, or number and name, of any building in any street, way, place, row of houses or block of buildings within the Administrative County of London shall be marked:—
  - (a) On the building, the entrance gate, boundary wall or fence immediately adjacent to the gate or entrance of such building, or in such other position as to be clearly viaible from the street or way in which the building is situate.
  - (b) With numerals or lettering of such colour as to contrast with the background against which they are displayed.
  - (c) With numerals or letters of sufficient size to render them clearly visible from the street or way in which the building is situate.
    - (d) In durable, non-absorbent material, which expression shall be deemed to include paint.
- (2) Where the number or name, or number and name, is marked on the building to which it relates, such number or name; or number and name, shall be not more than 20 feet above the level of the ground.
- (3) Where the number or name, or number and name, is marked in a position other than on the building to which it relates, such number or name, or number and name, shall be not more than 8 feet or less than 2 feet 6 inches above the level of the ground.
  - (4) The numerals of which any number is composed shall be arabic in character.
