Please describe the current use of the site:

It is important to describe the designated use of the flat within the context of the museum building and the mixed and intermingled use of residential and museum space. The flat is made up of three small rooms that are not all adjoined, with the kitchen in a separate area and located across a shared corridor and the bedroom off the shared corridor and landing. This means that there is no defined boundary between the existing residential use and the museum use. In terms of access, the flat and the museum share a main entrance door at ground level and a staircase. This staircase and the adjacent landings at first floor level provide access into the main areas of the museum, including office areas on the first floor where access is only permitted to museum staff. The gross internal floor area of the flat is approximately 34 square metres. The flat has not been used as residential space since 2014. Since then it has been used for museum administrative and storage space.
