The proposal consists of 3 small changes: 1) to add a "Conservation style" Velux window on the side pitched roof of the building, to let some light in the hallway of the top floor flat; 2) to block an existing window on the side of the building, to reduce the heat loss and increase privacy in the same hallway of the top floor flat; 3) to add a canopy in keeping with the style of the property, over the existing suspended metal side passageway that gives access to the flats at first and second (top) floor, in order to improve the look of such passageway, giving repair from rain and reducing views/screening from the neighbouring side building with all its cables, pipework and service windows (common staircase, wc and kitchens).

9. Materials

Description of *existing* materials and finishes:

Terracotta tiled pitched roof. External suspended metal passageway is currently open (no cover).

Description of *proposed* materials and finishes:

A Conservation style Velux window is proposed on the roof side, in order to give light to a dark hallway at top floor flat. Moreover, the external metal passageway would be covered with a wrought iron glazed canopy (polycarbonate would be preferable to glass as it is lighter and does not break with the thermal expansion of the metal structure).

Timber single glazed sash window on the side of the building

Description of *proposed* materials and finishes:

The proposal would block with matching bricks the existing window on the side of the building, as this is not letting much light in, and disperses warmth in winter. Moreover it faces a nearby (2,2m distance) property with many service windows and is therefore opaque and always stays closed for privacy reasons.
