Installation of new double-glazed (toughed glass) french doors and side casement window, where existing single door (upper half of door glazed with single pane glass) and side casement window are currently.
The new French door and side window will be designed to fit within the constraints of the existing lintel whilst maintaining a sympathetic profile using traditional timber joinery.
The design will require the removal of a single column of brickwork between the current side casement window and door.
Site is at the rear of the property leading from a small room, currently used as a bedroom, and onto a roof terrace owned and used solely by the occupier of the first floor flat.
The new doors will be wood (like the existing) and be the same colour as the current window and doors (matte white). the perimeter of the new opening will be made good and the surrounding back wall's appearance will not change.
