It is proposed to remove the previous addition of a timber frame conservatory to the existing house. This was approved in application 2017/1426/P & 2017/1848/L. All proposed internal alterations work were show on the previously approved drawings. No further demolition is required under this new application.

The proposal is to demolish the existing timber framed conservatory and replace it with a timber frame garden room to increase the living space. This proposal was approved in application 2017/1426/P & 2017/1848/L. No further demolition beyond that which has already been approved.
