**ENFORCEMENT NOTICE**

**ISSUED BY: THE LONDON BOROUGH OF CAMDEN**

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.
  
2. **THE LAND TO WHICH THE NOTICE RELATES**  
  
**Land at: 5 Chetwynd Villas, Chetwynd Road, London, NW5 1BT**  
shown outlined in black on the attached plan ("the Property").
  
3. **THE BREACH OF PLANNING CONTROL ALLEGED**  
  
**Without planning permission:** erection of a new building at the back of the garden over 2.5m high.
  
4. **REASONS FOR ISSUING THIS NOTICE:**  
  
It appears to the Council that the above breach of planning control has occurred within the last 4 years:
  - b) The single-storey outbuilding located in the rear garden, by reason of its scale and location is an overly dominant and incongruous form of development which neither preserves nor enhances the character or appearance of the surrounding area, contrary to policies D1 (Design) and D2 (Heritage) of the Camden Local Plan 2017.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

**5. WHAT YOU ARE REQUIRED TO DO**

Within a period of three (3) months of the Notice taking effect:

1. Completely remove the single-storey outbuilding located in the rear garden.
2. Make good the site following completion of the above works

**6. WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **20<sup>th</sup> April 2018** unless an appeal is made against it beforehand.
