We are applying for permission for a 3meter reduction in the height and a 1meter reduction in the lateral branches of the tree.

The tree has grown very large and the canopy is very sparse with some branches that are dead. the tree looks very top heavy and is largely shading the back of the garden a reduction would allow more light into the back of the garden allowing other shrubs and plants to grow with the extra light that would given by a reduction.
