There is documented evidence to prove that the terrace above the roof of the 2nd & 3rd floor flat, 28 Montpelier Grove, has existed and been in continuous use for over 10 years, making it immune from enforcement and a lawful development.

Evidence to prove the age and use of the terrace has been provided:

An aerial photo of the roof terrace, taken on 19/09/2002, as confirmed by Getmapping plc.

Photo taken from the street by Googlemaps in June 2008, showing the terrace railings adjacent to the roof terrace.

Statutory Declaration from the previous owner of the 2nd & 3rd Floor Flat, 28 Montpelier Grove, declaring that the terrace has been continuously used as an amenity space since it was acquired on the 8th of December, 1981.

Signed testimony from the Leaseholder of the First Floor Flat, 28 Montpelier Grove that the roof terrace has been in continuous use as an amenity space since they acquired their flat in the year 2000.
