T3 Syringa (Lilac) - Fair/poor - Fungal infection in main stem - Prune out main stem, reduce to 4m.

T4 Limes and other vegetation - Fair - Prune back to boundary.

T5 Tilia sp. (Lime) - Fair: Pollard - Re-pollard, remove suckers.
