When I first saw the Camden yellow Planning notice, affixed to the small tree outside 43 Kingsgate Road, yesterday evening, I initially assumed that this was a new application and wondered why I had not been notified of this through the Camden Email Alert system. But to my surprise, I discovered that this notice refers to an aplication, which I had thought was no longer valid; given the date of submission and the Government's instructions that this type of application should be determined within eight weeks.

But I was even more surpised to find that this very recently erected notice, in a position I pass by several times a day, stated that comments should be recieved by the "6th June"!; as this seems to be an unfortunate repetition of the communication problems, which led to my complaints to the, then, case officer and to your Director (see copies att).

I trust that you will able to supply an explanation for this current comunication problem, which will not require me to make a complaint to the Local Government Ombudsman as to this repeated lack of 'consultation transparency', if not actual maladministration, within the Local Planning Authority.

But of more pressing importance, I require your urgent assurance that consultation responses will still to be considered. I am, therefore, directing your attention to the detailed objection I submitted in respect of the previous application 2016/4318/P; which I posted, by 'signed for delivery' to Fiona Davies, on 9/2/2018 to serve as a 'holding objection' to this current application. Unfortunately, I cannot copy this directly to you at present, as I am awaiting a replacement battery 'to reboot' my older computer on which this document is stored.


