T1 1 Sycamore Acer pseudoplatanus Front This semi-mature tree is growing from the boundary wall, due to the expansion of the root bole the adjacent section of the wall is showing new cracks which are now compromising the structure and safety to the public. The tree has been in decline for the last three growing seasons, on my recent visit the there was showing around 20% of foliage left on the crown therefore limiting the trees ability to produce the necessary sugars. Suggested Works: Fell in sections to ground level using rigging equipment to ensure a controlled take down. Grind down stump to approx. 300mm below ground level
