I enclose an application to fell a sycamore tree at the above address.

The back extension of no 9 is being affected by subsidence and in January our insurance company identified that the damage was being caused by 2 poplars , one at no 9 and one at no 10 .They applied for permission to remove these trees which was granted (2018/0391/T and 2018/0248/T. We have been in negotiation about this because if at all possible we wanted to preserve these trees, as we consider them to be a valuable amenity, not only to us but to the wider area. As far as the Poplar tree in our garden is concerned the insurance company have agree that instead of felling, it can be reduced. We think that a similar course of action will be taken with the poplar in the garden of no10.

Between the 2 poplars is the sycamore, to which this application refers. We request that in view of the poplars not being felled, permission be given for its removal.
