T2-Bay tree- Prune back side over garden with poles from ground level, pull out climber with poles if possible. (One metre reduction)

T3-Lime tree- Prune back low overhanging branches to boundary. (Up to two metres to be pruned)

T5-Eucalyptus tree- Reduce upright trunk back to a suitable growth point within approximately two metres from leaning trunk, Reduce remainder of tree by approximately two metres and remove climbing Rose.6

T6-Holly tree- Shape with hedge trimmers (50cm reduction)

T7- Lilac tree- Light reduction (50cm) prune back Grape vine.
